Membership Registration

Terms of Application:

Membership is voluntary, confidential and by invitation of the Board of Directors. Members support, in general, the activities of the Association.

Membership Area:

The membership area for voting members is the Vail community located in the Town of Vail and adjacent developed areas from Vail Pass, on the East, Dowd Junction, on the West and the United States Forest Service boundaries on the North and South. Vail residency is not required for affiliate members.

Eligibility:

Individuals owning residential property within the membership area are eligible for a voting membership. Association memberships are available for condominium associations or a group of property owners within the membership area. Affiliated memberships are also available. Residency within the membership area is not required for affiliate members.

Membership Dues:

Annual membership dues for associations and voting members are \$1,000. Preferred date of annual dues payment for budgetary purposes is January 15th of each year. Members may reserve by prearrangement an annual dues payment date other than January 15th. Additional contribution amounts above the voting membership dues are allowed and appreciated. Affiliate members may contribute an amount of their choosing. New member dues paid within the fourth quarter are applied to the following year.

Membership Annual Meeting and Election of Board of Directors:

The Annual Meeting of the membership is held in Vail during December of each year. The annual election of the Board of Directors by voting members is held annually in November.

Membership Services:

The Association informs members on a timely basis about issues that are of concern to residential property owners. It provides technical, organizational and advisory assistance to its members and affiliates with respect to these issues. An Annual Report is prepared and distributed by e-mail, fax or U.S. mail to the membership and constituencies. Periodic reports, as needed during the year, are distributed by e-mail or U.S. mail to the membership. Reports and other sources of information are available on the Association's web site. The Association's Executive Director is available to assist members with respect to activities of concern to the Association.

Communications:

Members that desire to be closely involved in the activities of the Association, or their designated contact persons, should be accessible by e-mail. Members are requested to provide the Association with a list of property owners with postal addresses, and the contact numbers and addresses of parties to be notified by e-mail.
